and that she became unconscious and then when she woke up. The suspects were taking her home to Myrtle Beach. [REDACTED] states that she was sick and bleeding and that her mother took her to the hospital Friday evening. [REDACTED] states that she is supposed to pay the suspects another \$1500 dollars on Saturday. [REDACTED] states that she is concerned because another female - A Brazilian with black curly hair was having the same procedure done after her. [REDACTED] states that the suspects are leaving the country on Monday and that she heard the suspects talking about doing more procedures this weekend. [REDACTED] stated that she decided a week ago about doing the procedure and that she went on-line and made contact with (CHICA) who was planning on conducting procedures in NMB. [REDACTED] stated that the procedure took place in the back bedroom of the Condo. [REDACTED] stated that the bedroom had a connected bathroom. [REDACTED] told me the website where I could find (CHICA)'s address - [REDACTED] stated that she had approx 10 cuts on her body. Dr [REDACTED] stated that the suspects possibly used a scalpel and suction device to perform the procedure. [REDACTED] was not in good enough shape to write a voluntary statement at this time. I left blank voluntary statement and advised her to fill it out and bring it to NMB Police Dept. Further investigation required. [REDACTED] stated that (NOVIA) was (CHICA)'s assistant (nurse). [REDACTED] provided brief description of (CHICA) and (NOVIA).
